

The 950 member families play an average of 40,000 rounds between the two courses. Westchester CC has a rich history and continues to be a leader in the golf world.

- Charged with running the entire junior clinic program for the 2002 season. This responsibility included scheduling, administration, and developing a teaching guide. We ran 26 clinics that had over 200 participants.
